TPFA issues municipal bonds to provide financing to construct office buildings, university dormitories, major equipment purchases, healthcare project grants, unemployment obligations, and for a variety of other needs. TPFA typically issues up to \$1 billion in debt annually and manages several billion dollars of outstanding debt obligations. TPFA has a focused mission, and work is typically project oriented.
